The method to be used to determine the order of priority in which each of the persons interested in purchasing any of the specified residential properties may select the residential property that the person wishes to purchase :

Persons interested in purchasing must personally attend the designated place where the sale will take place to select the residential property that the person wishes to purchase. The Vendor does not accept any person having queued up at the place where the sale will take place before the Time of the Sale on the date concerned.

有意購買人士必須親臨賣方指定的出售地點揀選其意欲購買的住宅物業。賣方不接受於相關日期出售時間前於出售地點排隊輪候的人士。

Priority of selection of specified residential property(ies) in respect of an interested person* will be determined by the number of residential properties intended to be purchased. A higher priority will be given to the interested person of whom the number of residential properties intended to be purchased is higher. If such numbers of residential properties of more than one interested person are the same, the priority among such persons will be determined by balloting.

*An interested person consisted of immediate family member. Immediate family member, in relation to an individual, means a spouse, parent, child or sibling of the individual.

*有意購買指明住宅物業的人士包括其家人。家人就任何個人而言，指其配偶、父母、子女或兄弟姊妹。

If there is no interested person in purchasing more than 1 specified residential property simultaneously, the above specified residential property(ies) will be sold on a first come first served basis. In case of any dispute, the Vendor reserves its absolute right to allocate the above residential property(ies) to any person interested in purchasing by any method (including balloting).
